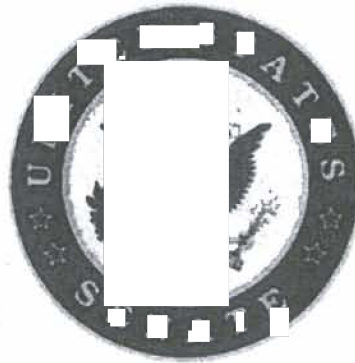

I am not aware of any other complaints referred to a court, administrative agency, professional association, disciplinary committee or other professional group. For the sake of transparency, I would note that during my confirmation process in 2007, an ethics panel was not in the least involved in my confirmation. I did appear on my own as a witness as Director of the OIG. I have been involved in the planning of the ongoing ethics awareness of IG total and I formed a panel during the confirmation process. I am not aware of any other complaints or investigations related to the same.

- o In 1994 a complaint was filed alleging that I had used my government position to obtain a substantial amount of information that I used for the benefit of a firm with which I was engaged in a business transaction. After a preliminary inquiry, the IC closed the matter with no further action.
- o In 1994 a complaint was filed alleging that I had improperly used my position as the Director of the National Security Council to obtain information for the benefit of a firm with which I was engaged in a business transaction. After a preliminary inquiry, the IC found that I was not found to have, and closed the matter with no further action.
- o In 1995 a complaint was filed alleging that my spouse and I had abused a government policy regarding computer use. Based on the preliminary inquiry, the IC found no violations of policies or regulations and the matter was closed with no further action.
- o In 1995 a complaint was filed alleging that I had improperly used my position as the Director of the National Security Council to obtain information for the benefit of a firm with which I was engaged in a business transaction. After a preliminary inquiry, the IC found that there had been no improper conduct and the matter was closed with no further action.
- o In 2004 a complaint was filed alleging that I had engaged in an improper relationship with a former subordinate and that I provided political assistance to that subordinate. Based on a preliminary inquiry, the IC found that the former subordinate was not an investigating and the matter was closed with no further action.

02. The Congressional committee charged with the oversight of the Intelligence Community considers and is responsible for the activities, programs and policies executed by the Intelligence Community. The legal obligation imposed by section 102 of the National Security Act of 1947 is to keep the Intelligence Community "fully and currently informed" of all U.S. intelligence activities (excepting secret activities that are covered by section 105) including "significant unreported intelligence activities" and "significant intelligence failures." The oversight process provides a necessary check and balance at the community level of the Intelligence Community, occurring between the Office of Intelligence Programs (OIP) and the Office of Intelligence Requirements (OIR) - an appropriate dialog with national policies. The relationship between the Intelligence Community and the Congressional oversight is mutually-beneficial. The obligation of the oversight is to ensure the national security, and it must be vigilant for potential abuse - particularly in the area of civil liberties.

03. BEING THE MOST RESPONSIBLE OF THE EXECUTIVES OF THE INTELLIGENCE COMMUNITY

The DDCI is responsible to the President for the performance of the entire Intelligence Community as an entity and to ensure, ultimately, that decisions are made - in the White House or in the field - are provided accurately through intelligence. This entails supervision and oversight of all aspects of the activities: collection and analysis, resource management, intelligence policy development, operational effectiveness, and compliance with the law. The DDCI also serves as the primary intelligence advisor to the President and is responsible for ensuring that the Congress is able to carry out its oversight of the Intelligence Community.

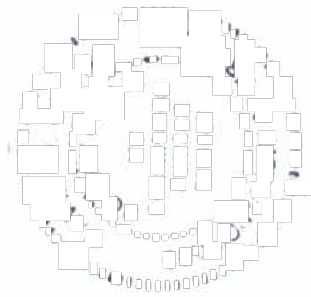
